Note: Our goal is to provide affordable international adoption alternatives. Some of the expenses are estimates and may vary by airfare changes, personal preferences, and special requests. Please understand that the fees below are subject to change and that many of them are out of our control. Agency fees do not include standard mileage charges.

- Fee 5 \$1,950 paid after official acceptance of the child referral

Agency Fee Payments (out-of-state agency fee is reduced by \$1,900)

- Fee 1 \$500 paid with application
- Fee 2 \$2,650 payable upon completion of home study
- Fee 3 \$2,650 paid when dossier is sent to Ukraine
- Fee 4 \$1,950 paid after official acceptance of the child referral

OFFICIAL FEES IN UKRAINE (06.17.2010 - THESE ARE ONLY BEST ESTIMATES AT THIS TIME)

Foreign Representative (Zhenia) Fees for adoption completed in Ukraine. **\$ 10,500**

This fee includes the following: translating and preparing the dossier for the SDA (State Department of Adoptions), notary services and other dossier related services in Ukraine, submitting the dossier and obtaining the registration number, obtaining the invitation letter from the SDA, transporting PAPs from airport to accommodations, escorting PAPs to the SDA to choose a child from the database, working in conjunction with the SDA to prepare referral and initiating the adoption process in the region, providing PAPs with mobile phones and sim cards (PAPs are responsible for minutes used), covering inspector's office expenses and work, covering expenses related to the court, obtaining the court adoption decree, obtaining and legislating new birth certificate, obtaining new social tax number for the child, obtaining an international passport for the child, mmedical visit for the child, working on Embassy documents, Interpreter and facilitator expenses including salary, orphanage donation, transportation expenses, transporting PAPs and child to airport upon completion of the process, and any other miscellaneous expenses that may be incurred.

*ALL FOREIGN FEES ARE PAYABLE IN FULL WHEN THE REFERRAL IS ACCEPTED AND WILL BE WIRED TO THE FPs IN UKRAINE BY NBICFS
